It is hereby notified for the information of all concerned female students of UG Batch-2022 enrolled at different Degree College of UT of Jammu and Kashmir that, in pursuance to the guidelines issued by the Directorate of Colleges, Higher Education Department, UT of J&K vide Notification No: DC-HE/2025/1772 dated: 01.09.2025 and University of Kashmir vide Notification No. F(BG-7th &8th Adm)Reg/KU/25 dated 18.08.2025, the admission to 4th year (Honors/Honors with Research) of the Four-Year Undergraduate Programme (FYUGP0 will Commence as per the following schedule:

Admission Forms shall be available at the admission Section, during working hours.
 Students must submit the filled forms, along with self-attested photocopies of qualifying marks sheets (up to 6th semester), CGPA record, two passport size photographs and any other required documents (category if any).

Programmes Offered:

A. Honours (without Research) Majors: Students may opt for 4th year Honours in the following subjects with intake of 40, except for education intake is 28.

B. Honours with Research Majors: Students fulfilling eligibility criteria may opt for 4th Year Honours with Research in the following subjects with intake of 40.

Eligibility Criteria:

1. For Honours (without Research):

All students of UG Batch 2022 who have successfully completed 6th Semester under FYUGP are eligible.

Promotion from 6th to 7th semester shall be subject to:

- Fulfilling the statutory attendance requirement in the preceding semester.
- Having backlog of not more than 50% of credits of study in the first five semesters (Backlog threshold as per promotion rules).
- Having passed the internal assessment of the preceding semester, wherever applicable.

2. For Honours with Research:

In addition to the above, students opting for Research Mode must:

- Have passed all courses up to 6th semester (no backlog allowed).
- Have secured a minimum CGPA of 7.5 or above till 6th semester.

Note: Final and detailed eligibility conditions will be issued by the University of Kashmir later

Important Instructions:

- Admissions will be granted strictly as per the guidelines issued by the Directorate of Colleges and affiliating University.
- For Research Verticals, selection shall be merit-based wherever the number of applications exceeds available seats (merit will be determined on the basis of CGPA up to 6th semester)
- A minimum batch strength of 10 students is required for operationalizing a major.

- Students are advised to carefully select their vertical (Honours or Research Honours) at the time of form submission.
- Any subsequent notifications or updates shall be made available on the College Website & Notice Boards.

Note: The candidates of earlier batches (general degree programme under Annual/Semester/CBCS mode) are also eligible but must have completed three-year Bachelor's programme.

Colleges listed in Annexures 'A' and 'B' as per DC-HE/2025/ 1152 dated 15-06-2025 are requested to issue admission notifications for students of other colleges/universities interested in seeking admission to 4th Year Honors or 4th Year Honors without research in their college. Students shall be required to submit admission applications **directly in the college** for seeking admission. Other colleges where Honors or Research verticals are not offered shall also inform their students about the same.

Note:

- The admission notices must clearly specify the list of programs available in your college for 4th Year, with Honors or Honors with Research as well as the eligibility criteria as laid down by your affiliating university.
- In case the number of applicants for a particular major exceed the number of vacancies available, such colleges shall grant admissions on the basis of merit obtained by the candidates up to the 6th Semester.
- Students willing to opt for 4th Year in either of the two verticals need to fulfil the eligibility criteria strictly as laid down by the respective affiliating universities/autonomous colleges.

- Confirmation of admissions would be subject to fulfilling the minimum enrolment criteria of a Major with or without research of being not less than 10 students in any case.
- All guidelines issued by the affiliating universities regarding the 4th year as well as the Intra and Inter-University Migration criteria should be strictly adhered to.
- In case the Minor field of study of a student is not offered by the college to which they are migrating, the colleges can: (a) Collaborate with a neighbouring college for offering the minor, or (b) offer blended/hybrid delivery using prescribed MOOCs or University-approved online modules in consultation with the Board of Studies.
- Colleges shall regularly update the vacancy positions on the portal to reflect the current vacancy positions in student interest till the completion of the admission process.
- All other terms and conditions notified earlier vide No: DC-HE/2025/ 1152 dated 15-06-2025 shall remain unchanged.
